The tuition waiver for high school seniors will cover the per credit hour tuition cost for up to six credit hours. All high school students are responsible for additional fees, plus parking permit, recreation fee and any additional charges, including books.

Concurrent Enrollment Guidelines

STEP 1 -- ADMISSION REQUIREMENTS

To be admitted as a concurrently enrolled student you must be able to satisfy all 15 curricular requirements and requirements for graduation no later than the spring semester of your senior year and meet the performance requirements listed below.

Performance Requirements:

Seniors: minimum ACT 19 (*see course placement*) or SAT 900

or 3.0 high school GPA (*on a 4.0 scale*)

(First semester of enrollment can be the summer before the senior year.)

Juniors: minimum ACT 21 (*see course placement*) or SAT 980

or 3.5 high school GPA (*on a 4.0 scale*)

(First semester of enrollment can be the summer before the junior year.)

Home Study or Unaccredited High School:

Seniors (17 years of age): minimum 19 ACT (*see course placement*) or 900 SAT

Juniors (16 years of age): minimum 21 ACT (*see course placement*) or 980 SAT

Curricular Requirements:

4 units English

(Grammar, Composition, Literature)

3 units Math

(Algebra I or above)

2 units History

(1 unit of American History)

2 units Lab Science

(excluding General Science)

1 units Citizenship Skills

(Econ., Geog., Govt., Non-western Culture)

3 units Other

(any of the above and/or Computer Science and/or Foreign Language)

STEP 2 -- COURSE PLACEMENT

To help ensure that you possess the skills necessary to be successful in college, you must have a 19 ACT subject score in English, Mathematics, and/or Science Reasoning to enroll in those courses. Additionally, you must have at least a 19 in Reading to enroll in any other collegiate course. **NOTE:** Students must have ACT scores which meet placement requirement for enrollment.

COURSE LOAD

A high school student may enroll in a combined number of high school and college courses per semester not to exceed a full-time college workload of 19 semester credit hours. For purposes of calculating workload, one-half high school unit shall be equivalent to three semester credit hours of college work.

In compliance with Oklahoma State Regents for Higher Education policy, OSU-OKC will waive tuition for up to six credit hours per term for any Oklahoma resident **high school senior** enrolled for fall, spring, or summer. Seniors are defined as students who have completed their junior year but have not yet graduated. To receive this waiver, student must complete a Tuition Waiver Request with his/her advisor at the time of enrollment.
