- 4. **Location:** The class will be held at the OSU-OKC Human Services Education Center located at 3401 W. Reno.
- 5. **Materials:** All course material is included in the course fee and will be distributed by the instructor.
- 6. **Operation:** OSU-OKC PDTC agrees to operate and conduct the school in accordance with rules for Commercial Driver Training, Department of Public Safety.
- 7. **Motorcycles:** The OSU-OKC PDTC maintains a fleet of motorcycles to be utilized by the Basic RiderCourseSM. Participants may utilize their personal motorcycle for the course with proof of liability insurance. Experienced RiderCourseSM participants are required to provide their own motorcycle for training and are responsible for fuel, lubricants, and insurance.
- 8. **Contract:** This instrument contains the entire contract between parties and no changes or amendments thereto shall be binding upon the parties, unless made in writing.

Note: All motorcycle *RiderCourses*SM require the operator have proper riding gear, which includes helmet, eye protection, full-fingered rider gloves, long-sleeve shirt or jacket, long pants and over the ankle footwear. Gear must be worn at every session. (Shoes or boots with leather soles are not recommended.) **No student will be allowed to ride any portion of the course without all of the listed items.**
